THE CHAIRPERSON OF THE WITNESS AND VICTIM PROTECTION AGENCY, Considering : a. whereas, based on the Decree Constitutional Court Number 103/PUU-XXI/2023, applications for compensation, medical assistance, or psychosocial and psychological rehabilitation can be submitted no later than 10 (ten) years since the Law Number 5 Year 2018 on the Amendments to the Law Number 15 Year 2003 on the Stipulation of Government Regulation in Lieu of the Law Number 1 Year 2002 on the Eradication of Criminal Acts of Law came into effect; Terrorism

> b. whereas, the provisions regarding the time limit for submitting applications for

compensation, medical assistance, psychosocial and psychological rehabilitation as regulated in the Regulation of the Witness and Victim Protection Agency Number 7 Year 2020 on the Procedures of Submission Review of Applications for Compensation, Medical Assistance, or Psychosocial and Psychological Rehabilitation for Victims Past Terrorism Crimes are no longer in accordance with legal developments, thus, requires to be amended;

c. whereas, based on the considerations as referred to in letter a and letter b, it is necessary to stipulate the Regulation of the Witness and Victim Protection Agency on the Amendments to the Regulation of the Witness and Victim Protection Agency Number 7 Year 2020 on the Procedures of Submission and Review of Applications for Compensation, Medical Assistance, or Psychosocial and Psychological Rehabilitation for Victims of Past Terrorism Crimes;

HEREBY DECIDED:

To stipulate: THE REGULATION OF THE WITNESS AND PROTECTION **AGENCY** THE ON AMENDMENT ТΟ THE REGULATION OF THE WITNESS AND VICTIM PROTECTION AGENCY NUMBER 7 YEAR 2020 ON THE PROCEDURES OF SUBMISSION AND REVIEW OF APPLICATIONS COMPENSATION, MEDICAL ASSISTANCE, OR PSYCHOSOCIAL AND PSYCHOLOGICAL REHABILITATION FOR VICTIMS OF PAST TERRORISM CRIMES.

Article T

The provisions of Article 5 of the Regulation of the Witness and Victim Protection Agency Number 7 Year 2020 on the Procedures of Submission and Review of Applications for Compensation, Medical Assistance, or Psychosocial and Psychological Rehabilitation for Victims of Past Terrorism Crimes (State Gazette of the Republic of Indonesia 2020 Number 1038) are amended to read as follows:

Article 5

- (1) Applications for Compensation, Medical Assistance, or Psychosocial Rehabilitation and Psychological Rehabilitation must be submitted no later than 22 June 2028.
- (2) If an application for Compensation, Medical Assistance, or Psychosocial Rehabilitation and Psychological Rehabilitation is submitted via mail, the submission as referred to in paragraph (1) shall be counted based on the mail stamp.

Article II

This Regulation of the Agency shall come into force on the date of its promulgation.

For public cognizance, ordering the promulgation of this Regulation of the Agency shall be published in the State Gazette of the Republic of Indonesia
